Enactment of this legislation may reduce the following for (1) federal funds approximately (\$607,000) one-time in FY 2026, (\$13,166,800) in FY 2027, (\$27,617,500) in FY 2028, and (\$27,613,400) ongoing in FY 2029 and (2) expendable receipts approximately (\$123,600) one-time in FY 2026 and (\$806,000) ongoing in FY 2027. The State may see a reduction of about (\$5,000,000) for each fine from the Centers for Medicare and Medicaid Services for enacting each statutory provision that is in conflict with federal law. Additionally, this legislation puts into statute provisions from the federal H.R. 1, the One Big Beautiful Bill Act, which may result in reductions of federal funds of (\$222,261,500) one-time in FY 2027 and (\$437,405,200) ongoing in FY 2028.

Enactment of this legislation may overall reduce expenditures for the State by around (\$1,316,400) total funds (\$585,800 General Fund) one-time in FY 2026, (\$14,403,900) total funds (\$797,200 General Fund) in FY 2027, (\$28,594,900) total funds (\$31,700 General Fund) in FY 2028, and (\$28,586,700) total funds (\$27,600 General Fund) ongoing in FY 2029 from serving (9,900) fewer Medicaid clients, (600) fewer clients receiving Supplemental Nutrition Assistance Program benefits,

adding 131 eligibility worker FTEs, and computer programming changes. Centers for Medicare and Medicaid Services may issue fines of about \$5,000,000 General Fund to the State for enacting each statutory provision that is in conflict with federal law. Additionally, this legislation puts into statute provisions from the federal H.R. 1, the One Big Beautiful Bill Act, which may result in reducing State expenditures by around (\$252,157,700) total funds (\$10,490,500 General Fund) in FY 2027 and (\$493,198,200) total funds (\$15,216,900 General Fund) from serving (33,100) fewer Medicaid clients, adding 184 eligibility worker FTEs, and computer programming changes.

Local Government

UCA 36-12-13(2)(c)

Enactment of this legislation may result in the State's local substance abuse and mental health authorities annually paying around (\$1,436,100) less to serve around (3,900) fewer Medicaid clients and receive less revenue of around (\$3,787,100) beginning in 2027. Additionally, this legislation puts into statute provisions from the federal H.R. 1, the One Big Beautiful Bill Act, which may result in the State's local substance abuse and mental health authorities annually paying around (\$1,583,400) less to serve around (4,300) fewer Medicaid clients and receive less revenue of around (\$4,175,600) beginning in 2027.

Individuals & Businesses

Enactment of this legislation likely will not result in direct expenditures from tax or fee changes for Utah residents and businesses.

Regulatory Impact
