Mr. Speaker:

The Transportation Committee reports a favorable recommendation on **1st Sub. S.B. 191**, TOW YARD AMENDMENTS, by Senator D. L. Ipson, with the following amendments:

Amendment 1

1 Line 195 through 201:

195 government-issued identification, to show that the individual is authorized to take
