A BILL

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Accelerating Access to*
5 *Dementia and Alzheimer’s Provider Training Act” or the*
6 *“AADAPT Act”.*

7 **SEC. 2. EXPANDING CAPACITY FOR HEALTH OUTCOMES.**

8 *(a) IN GENERAL.—Section 330N of the Public Health*
9 *Service Act (42 U.S.C. 254c–20) is amended—*

10 *(1) in subsection (a)(1), by striking “entities”*
11 *and inserting “entities, including a public or non-*
12 *profit private entity,”; and*

13 *(2) in subsection (b), by inserting “dementia*
14 *care,” after “palliative care,”.*

15 *(b) AUTHORIZATION OF APPROPRIATIONS.—Section*
16 *330N(k) of the Public Health Service Act (42 U.S.C. 254c–*
17 *20(k)) is amended by striking “fiscal years 2022 through*
18 *2026” and inserting “fiscal years 2027 through 2031”.*
