# **A BILL**

To repeal the Corporate Transparency Act.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Repealing Big Brother*  
5 *Overreach Act”.*

6 **SEC. 2. BENEFICIAL OWNERSHIP INFORMATION REPORT-**  
7 **ING REQUIREMENTS.**

8        (a) *IN GENERAL.*—*Section 5336 of title 31, United*  
9 *States Code, is amended—*

10            (1) *by inserting “foreign” after “Beneficial” each*  
11 *place such term appears in heading or text;*

12            (2) *by inserting “foreign” after “beneficial” each*  
13 *place such term appears in heading or text (and con-*  
14 *forming the item relating to such section 5336 in the*  
15 *table of contents for chapter 53 of title 31, United*  
16 *States Code, accordingly); and*

17            (3) *in subsection (a)—*

18                    (A) *in paragraph (3)(A), by inserting after*  
19 *“individual who” the following: “is a foreign*  
20 *person and”;* and

21                    (B) *in paragraph (11)(A), by striking “that*  
22 *is” and all that follows through “(ii) formed”*  
23 *and inserting “that is formed”.*

24        (b) *DELETION OF DATA RELATING TO NON-REPORTING*  
25 *COMPANIES.*—*Not later than 90 days after the date of en-*

1 *actment of this Act, the Financial Crimes Enforcement Net-*  
2 *work shall delete all beneficial ownership information col-*  
3 *lected pursuant to section 5336 of title 31, United States*  
4 *Code, with respect to—*

5           (1) *any individual who is not a foreign bene-*  
6 *ficial owner (as such term is defined under such sec-*  
7 *tion 5336); or*

8           (2) *a corporation, limited liability company, or*  
9 *other similar entity that is not a reporting company*  
10 *(as such term is defined under such section 5336).*
