A BILL

To reauthorize the Kay Hagan Tick Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REAUTHORIZATION OF PROGRAMS.**

4 (a) NATIONAL STRATEGY AND REGIONAL CENTERS
5 OF EXCELLENCE IN VECTOR-BORNE DISEASE.—Section
6 317U of the Public Health Service Act (42 U.S.C. 247b–
7 23) is amended—

8 (1) in subsection (b), in the matter preceding
9 paragraph (1), by striking “the Tick-Borne Disease
10 Working Group established under section 2062 of
11 the 21st Century Cures Act (42 U.S.C. 284s) and
12 other individuals, as appropriate” and inserting “ap-
13 propriate individuals”;

14 (2) in subsection (c)(4), by inserting “, includ-
15 ing by increasing capacity to identify, report, pre-
16 vent, and respond to such diseases” before the pe-
17 riod at the end; and

18 (3) in subsection (f), by striking “2021 through
19 2025” and inserting “2026 through 2030”.

20 (b) ENHANCED SUPPORT TO ASSIST HEALTH DE-
21 PARTMENTS IN ADDRESSING VECTOR-BORNE DIS-
22 EASES.—Section 2822(c) of the Public Health Service Act
23 (42 U.S.C. 300hh–32(c)) is amended by striking “2021
24 through 2025” and inserting “2026 through 2030”.
