A BILL

To amend the Securities Act of 1933 with respect to small
company capital formation, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Regulation A+ Improve-*
5 *ment Act of 2025”.*

6 **SEC. 2. JOBS ACT-RELATED EXEMPTION.**

7 *Section 3(b) of the Securities Act of 1933 (15 U.S.C.*
8 *77c(b)) is amended—*

9 *(1) in paragraph (1), by striking “\$5,000,000”*
10 *and inserting “\$50,000,000, including not more than*
11 *\$12,000,000 offered by all selling security holders that*
12 *are affiliates of the issuer, as such dollar amounts are*
13 *adjusted for inflation by the Commission every 5*
14 *years, by notice published in the Federal Register, to*
15 *the nearest \$10,000 to reflect the change in the Con-*
16 *sumer Price Index for All Urban Consumers pub-*
17 *lished by the Bureau of Labor Statistics”;*

18 *(2) in paragraph (2)(A), by striking*
19 *“\$50,000,000” and inserting “\$150,000,000, includ-*
20 *ing not more than \$50,000,000 offered by all selling*
21 *security holders that are affiliates of the issuer, as*
22 *such dollar amounts are adjusted for inflation by the*
23 *Commission every 5 years, by notice published in the*
24 *Federal Register, to the nearest \$10,000 to reflect the*
25 *change in the Consumer Price Index for All Urban*

1 *Consumers published by the Bureau of Labor Statis-*
2 *tics*"; and

3 (3) *in paragraph (5)—*

4 (A) *by striking "such amount as" and in-*
5 *serting "such amount, in addition to the adjust-*
6 *ment for inflation provided for under such para-*
7 *graph (2)(A), as"; and*

8 (B) *by striking "such amount, it" and in-*
9 *serting "such amount, in addition to the adjust-*
10 *ment for inflation provided for under such para-*
11 *graph (2)(A), it".*
