A BILL

To restrict the establishment of triumphal arches within certain areas of the District of Columbia and the capital region, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Arlington National
5 Cemetery Viewshed Protection Act”.

1 **SEC. 2. RESTRICTION ON TRIUMPHAL ARCHES IN THE CAP-**
2 **ITAL REGION.**

3 (a) LADY BIRD JOHNSON PARK, DISTRICT OF CO-
4 LUMBIA.—

5 (1) IN GENERAL.—Notwithstanding any other
6 provision of law, the establishment or construction of
7 a triumphal arch within Lady Bird Johnson Park is
8 prohibited, without regard to the source of funds for
9 such establishment or construction.

10 (2) PROHIBITION ON FUNDS.—No Federal
11 funds may be made available for the establishment
12 or construction of a triumphal arch within Lady
13 Bird Johnson Park.

14 (b) PROHIBITION ON CERTAIN MONUMENTS.—No
15 triumphal arch with a height in excess of 50 feet may be
16 established or constructed on land administered by the
17 National Capital Region Office of the National Park Serv-
18 ice except by express authorization of Congress.

19 (c) DEFINITIONS.—In this section:

20 (1) LADY BIRD JOHNSON PARK.—The term
21 “Lady Bird Johnson Park” means Lady Bird John-
22 son Park, formerly known as Columbia Island, in
23 the District of Columbia.

24 (2) TRIUMPHAL ARCH.—The term “triumphal
25 arch” means a monumental structure consisting of

- 1 at least one freestanding archway, or a substantially
- 2 similar structure.
