Mr. OGLES (for himself, Mr. CLINE, Mr. TIFFANY, Mr. BILIRAKIS, Mr. SESSIONS, and Mr. ROY) introduced the following bill; which was referred to the Committee on Oversight and Government Reform

A BILL

To designate Tiananmen Square Memorial Boulevard in Washington, District of Columbia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Tiananmen Square
5 Memorial Act of 2026”.

6 **SEC. 2. DESIGNATION OF TIANANMEN SQUARE MEMORIAL**
7 **BOULEVARD.**

8 (a) DESIGNATION OF BOULEVARD.—

9 (1) IN GENERAL.—The area along International
10 Place Northwest between 3501 International Place

1 Northwest and 3507 International Place Northwest
2 in Washington, District of Columbia, shall be known
3 and designated as “Tiananmen Square Memorial
4 Boulevard”.

5 (2) REFERENCES.—Any reference in a law,
6 map, regulation, document, paper, or other record of
7 the United States to the area referred to in para-
8 graph (1) shall be deemed to be a reference to
9 Tiananmen Square Memorial Boulevard.

10 (b) DESIGNATION OF ADDRESS.—

11 (1) DESIGNATION.—The address of 3505 Inter-
12 national Place Northwest, Washington, District of
13 Columbia, shall be redesignated as 1 Tiananmen
14 Square Memorial Boulevard.

15 (2) REFERENCES.—Any reference in a law,
16 map, regulation, document, paper, or other record of
17 the United States to the address referred to in para-
18 graph (1) shall be deemed to be a reference to 1
19 Tiananmen Square Memorial Boulevard.

20 (c) SIGNS.—The Administrator of General Services
21 shall construct street signs that shall—

22 (1) contain the phrase “Tiananmen Square Me-
23 morial Boulevard”;

1 (2) be similar in design to the signs used by the
2 District of Columbia to designate the location of
3 Metro stations; and

4 (3) be placed on—

5 (A) the parcel of Federal property that is
6 closest to 1 Tiananmen Square Memorial Bou-
7 levard (as redesignated by subsection (b)(1));
8 and

9 (B) the street corners of International
10 Drive Northwest and Van Ness Street North-
11 west and International Drive Northwest and
12 International Place Northwest in Washington,
13 District of Columbia.
