A BILL

To amend title XVIII of the Social Security Act to ensure that facilities do not lose critical access hospital status as a result of a roadway or transportation infrastructure improvement.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Critical Access Hos-
5 pital Roadway Impact Protections Act of 2026” or the
6 “Critical Access Hospital RIP Act of 2026”.

1 **SEC. 2. ENSURING THAT FACILITIES DO NOT LOSE CRIT-**
2 **ICAL ACCESS HOSPITAL STATUS AS A RESULT**
3 **OF A ROADWAY OR TRANSPORTATION INFRA-**
4 **STRUCTURE IMPROVEMENT.**

5 Section 1820(c)(2) of the Social Security Act (42
6 U.S.C. 1395i-4(c)(2)) is amended by adding at the end
7 the following new subparagraph:

8 “(F) DISREGARD OF SUBSEQUENT ROAD-
9 WAY OR TRANSPORTATION INFRASTRUCTURE
10 IMPROVEMENTS.—

11 “(i) IN GENERAL.—A facility that is
12 or at any point was designated as a critical
13 access hospital by a State under subpara-
14 graph (B) that would meet the criterion
15 specified in clause (i)(I) of such subpara-
16 graph but for a roadway or transportation
17 infrastructure improvement completed on
18 or after the date of such designation shall
19 be deemed to continue to meet such cri-
20 terion.

21 “(ii) ROADWAY OR TRANSPORTATION
22 INFRASTRUCTURE IMPROVEMENT DE-
23 FINED.—For purposes of clause (i), the
24 term ‘roadway or transportation infra-
25 structure improvement’ includes—

1 “(I) the construction, realign-
2 ment, widening, or enhancement of a
3 highway or roadway; and

4 “(II) the construction or modi-
5 fication of a bridge, overpass, or tun-
6 nel.”.
