A BILL

To authorize appropriations for fiscal year 2027 for intelligence and intelligence-related activities of the United States Government, the Intelligence Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) SHORT TITLE.—This Act may be cited as the
5 “Intelligence Authorization Act for Fiscal Year 2027”.

6 (b) TABLE OF CONTENTS.—The table of contents for

1 (c) AUTOMATIC EXECUTION OF CLERICAL
2 CHANGES.—Except as otherwise expressly provided, when
3 an amendment made by this Act amends an Act to add
4 a section or larger organizational unit to that Act, repeals
5 or transfers a section or larger organizational unit in that
6 Act, or amends the designation or heading of a section
7 or larger organizational unit in that Act, that amendment
8 also shall have the effect of amending any table of con-
9 tents of that Act to alter the table to conform to the
10 changes made by the amendment.

11 **SEC. 2. DEFINITIONS.**

12 In this Act:

13 (1) CONGRESSIONAL INTELLIGENCE COM-
14 MITTEE.—The term “congressional intelligence com-
15 mittees” has the meaning given such term in section
16 3 of the National Security Act of 1947 (50 U.S.C.
17 3003).

1 (2) INTELLIGENCE COMMUNITY.—The term
2 “intelligence community” has the meaning given
3 such term in section 3 of the National Security Act
4 of 1947 (50 U.S.C. 3003).

5 **TITLE I—INTELLIGENCE**
6 **ACTIVITIES**

7 **SEC. 101. AUTHORIZATION OF APPROPRIATIONS.**

8 Funds are hereby authorized to be appropriated for
9 fiscal year 2027 for the conduct of the intelligence and
10 intelligence-related activities of the Federal Government.

11 **SEC. 102. CLASSIFIED SCHEDULE OF AUTHORIZATIONS.**

12 (a) SPECIFICATIONS OF AMOUNTS.—The amounts
13 authorized to be appropriated under section 101 for the
14 conduct of the intelligence activities of the Federal Gov-
15 ernment are those specified in the classified Schedule of
16 Authorizations prepared to accompany this Act.

17 (b) AVAILABILITY OF CLASSIFIED SCHEDULE OF AU-
18 THORIZATIONS.—

19 (1) AVAILABILITY.—The classified Schedule of
20 Authorizations referred to in subsection (a) shall be
21 made available to the Committee on Appropriations
22 of the Senate, the Committee on Appropriations of
23 the House of Representatives, and to the President.

24 (2) DISTRIBUTION BY THE PRESIDENT.—Sub-
25 ject to paragraph (3), the President shall provide for

1 suitable distribution of the classified Schedule of Au-
 2 thorizations referred to in subsection (a), or of ap-
 3 propriate portions of such Schedule, within the exec-
 4 utive branch of the Federal Government.

5 (3) LIMITS ON DISCLOSURE.—The President
 6 shall not publicly disclose the classified Schedule of
 7 Authorizations or any portion of such Schedule ex-
 8 cept—

9 (A) as provided in section 601(a) of the
 10 Implementing Recommendations of the 9/11
 11 Commission Act of 2007 (50 U.S.C. 3306(a));

12 (B) to the extent necessary to implement
 13 the budget; or

14 (C) as otherwise required by law.

15 **SEC. 103. INTELLIGENCE COMMUNITY MANAGEMENT AC-**
 16 **COUNT.**

17 (a) AUTHORIZATION OF APPROPRIATIONS.—There is
 18 authorized to be appropriated for the Intelligence Commu-
 19 nity Management Account of the Director of National In-
 20 telligence for fiscal year 2027 the sum of \$591,000,000.

21 (b) CLASSIFIED AUTHORIZATION OF APPROPRIA-
 22 TIONS.—In addition to amounts authorized to be appro-
 23 priated for the Intelligence Community Management Ac-
 24 count by subsection (a), there are authorized to be appro-
 25 priated for the Intelligence Community Management Ac-

1 count for fiscal year 2027 such additional amounts as are
2 specified in the classified Schedule of Authorizations re-
3 ferred to in section 102(a).

4 **TITLE II—CENTRAL INTEL-**
5 **LIGENCE AGENCY RETIRE-**
6 **MENT AND DISABILITY SYS-**
7 **TEM**

8 **SEC. 201. AUTHORIZATION OF APPROPRIATIONS.**

9 There is authorized to be appropriated for the Cen-
10 tral Intelligence Agency Retirement and Disability Fund
11 \$514,000,000 for fiscal year 2027.

12 **TITLE III—INTELLIGENCE**
13 **COMMUNITY MATTERS**

14 **SEC. 301. RESTRICTION ON CONDUCT OF INTELLIGENCE**
15 **ACTIVITIES.**

16 The authorization of appropriations by this Act shall
17 not be deemed to constitute authority for the conduct of
18 any intelligence activity which is not otherwise authorized
19 by the Constitution or the laws of the United States.

20 **SEC. 302. INCREASE IN EMPLOYEE COMPENSATION AND**
21 **BENEFITS AUTHORIZED BY LAW.**

22 Appropriations authorized by this Act for salary, pay,
23 retirement, and other benefits for Federal employees may
24 be increased by such additional or supplemental amounts

- 1 as may be necessary for increases in such compensation
- 2 or benefits authorized by law.
