Res. 1383) commemorating the one-year anniversary of the enactment of the Working Families Tax Cuts; and for other purposes.

Mr. AUSTIN SCOTT of Georgia, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 8800) to authorize appropriations for fiscal year 2027 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for

such fiscal year, and for other purposes; providing for consideration of the bill (H.R. 8595) making appropriations for national security, Department of State, and related programs for the fiscal year ending September 30, 2027, and for other purposes; providing for consideration of the bill (H.R. 8884) to amend title II of the Social Security Act to reauthorize demonstration authority for the disability insurance program; providing for consideration of the resolution (H. Res. 1383) commemorating the one-year anniversary of the enactment of the Working Families Tax Cuts; and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
 2 lution the Speaker may, pursuant to clause 2(b) of rule
 3 XVIII, declare the House resolved into the Committee of
 4 the Whole House on the state of the Union for consider-
 5 ation of the bill (H.R. 8800) to authorize appropriations
 6 for fiscal year 2027 for military activities of the Depart-
 7 ment of Defense, for military construction, and for defense
 8 activities of the Department of Energy, to prescribe mili-
 9 tary personnel strengths for such fiscal year, and for other
 10 purposes. The first reading of the bill shall be dispensed
 11 with. All points of order against consideration of the bill
 12 are waived. General debate shall be confined to the bill
 13 and amendments specified in this section and shall not ex-
 14 ceed one hour equally divided and controlled by the chair
 15 and ranking minority member of the Committee on Armed
 16 Services or their respective designees. After general debate
 17 the bill shall be considered for amendment under the five-

1 minute rule. In lieu of the amendment in the nature of
2 a substitute recommended by the Committee on Armed
3 Services now printed in the bill, an amendment in the na-
4 ture of a substitute consisting of the text of Rules Com-
5 mittee Print 119–33 shall be considered as adopted in the
6 House and in the Committee of the Whole. The bill, as
7 amended, shall be considered as the original bill for the
8 purpose of further amendment under the five-minute rule
9 and shall be considered as read. All points of order against
10 provisions in the bill, as amended, are waived.

11 SEC. 2. (a) No further amendment to H.R. 8800, as
12 amended, shall be in order except those printed in part
13 A of the report of the Committee on Rules accompanying
14 this resolution, amendments en bloc described in section
15 3 of this resolution, and pro forma amendments described
16 in section 4 of this resolution.

17 (b) Each further amendment printed in part A of the
18 report of the Committee on Rules shall be considered only
19 in the order printed in the report, may be offered only
20 by a Member designated in the report, shall be considered
21 as read, shall be debatable for the time specified in the
22 report equally divided and controlled by the proponent and
23 an opponent, shall not be subject to amendment except
24 as provided by section 4 of this resolution, and shall not

1 be subject to a demand for division of the question in the
2 House or in the Committee of the Whole.

3 (c) All points of order against further amendments
4 printed in part A of the report of the Committee on Rules
5 or against amendments en bloc described in section 3 of
6 this resolution are waived.

7 SEC. 3. It shall be in order at any time for the chair
8 of the Committee on Armed Services or his designee to
9 offer amendments en bloc consisting of further amend-
10 ments printed in part A of the report of the Committee
11 on Rules accompanying this resolution not earlier disposed
12 of. Amendments en bloc offered pursuant to this section
13 shall be considered as read, shall be debatable for 40 min-
14 utes equally divided and controlled by the chair and rank-
15 ing minority member of the Committee on Armed Services
16 or their respective designees, shall not be subject to
17 amendment except as provided by section 4 of this resolu-
18 tion, and shall not be subject to a demand for division
19 of the question in the House or in the Committee of the
20 Whole.

21 SEC. 4. During consideration of H.R. 8800 for
22 amendment, the chair and ranking minority member of
23 the Committee on Armed Services or their respective des-
24 ignees may offer up to 10 pro forma amendments each
25 at any point for the purpose of debate.

1 SEC. 5. At the conclusion of consideration of H.R.
2 8800 for amendment the Committee shall rise and report
3 the bill, as amended, to the House with such further
4 amendments as may have been adopted. The previous
5 question shall be considered as ordered on the bill, as
6 amended, and on any further amendment thereto to final
7 passage without intervening motion except one motion to
8 recommit.

9 SEC. 6. At any time after adoption of this resolution
10 the Speaker may, pursuant to clause 2(b) of rule XVIII,
11 declare the House resolved into the Committee of the
12 Whole House on the state of the Union for consideration
13 of the bill (H.R. 8595) making appropriations for national
14 security, Department of State, and related programs for
15 the fiscal year ending September 30, 2027, and for other
16 purposes. The first reading of the bill shall be dispensed
17 with. All points of order against consideration of the bill
18 are waived. General debate shall be confined to the bill
19 and shall not exceed one hour equally divided and con-
20 trolled by the chair and ranking minority member of the
21 Committee on Appropriations or their respective des-
22 ignees. After general debate the bill shall be considered
23 for amendment under the five-minute rule. The bill shall
24 be considered as read. Points of order against provisions

1 in the bill for failure to comply with clause 2 or clause
2 5(a) of rule XXI are waived.

3 SEC. 7. (a) No amendment to H.R. 8595 shall be in
4 order except those printed in part B of the report of the
5 Committee on Rules accompanying this resolution, amend-
6 ments en bloc described in section 8 of this resolution, and
7 pro forma amendments described in section 9 of this reso-
8 lution.

9 (b) Each amendment printed in part B of the report
10 of the Committee on Rules shall be considered only in the
11 order printed in the report, may be offered only by a Mem-
12 ber designated in the report, shall be considered as read,
13 shall be debatable for the time specified in the report
14 equally divided and controlled by the proponent and an
15 opponent, shall not be subject to amendment except as
16 provided by section 9 of this resolution, and shall not be
17 subject to a demand for division of the question in the
18 House or in the Committee of the Whole.

19 (c) All points of order against amendments printed
20 in part B of the report of the Committee on Rules or
21 against amendments en bloc described in section 8 of this
22 resolution are waived.

23 SEC. 8. It shall be in order at any time for the chair
24 of the Committee on Appropriations or his designee to
25 offer amendments en bloc consisting of amendments print-

1 ed in part B of the report of the Committee on Rules ac-
2 companying this resolution not earlier disposed of. Amend-
3 ments en bloc offered pursuant to this section shall be con-
4 sidered as read, shall be debatable for 20 minutes equally
5 divided and controlled by the chair and ranking minority
6 member of the Committee on Appropriations or their re-
7 spective designees, shall not be subject to amendment ex-
8 cept as provided by section 9 of this resolution, and shall
9 not be subject to a demand for division of the question
10 in the House or in the Committee of the Whole.

11 SEC. 9. During consideration of H.R. 8595 for
12 amendment, the chair and ranking minority member of
13 the Committee on Appropriations or their respective des-
14 ignees may offer up to 10 pro forma amendments each
15 at any point for the purpose of debate.

16 SEC. 10. At the conclusion of consideration of H.R.
17 8595 for amendment the Committee shall rise and report
18 the bill to the House with such amendments as may have
19 been adopted. The previous question shall be considered
20 as ordered on the bill and amendments thereto to final
21 passage without intervening motion except one motion to
22 recommit.

23 SEC. 11. Upon adoption of this resolution it shall be
24 in order to consider in the House the bill (H.R. 8884)
25 to amend title II of the Social Security Act to reauthorize

1 demonstration authority for the disability insurance pro-
2 gram. All points of order against consideration of the bill
3 are waived. In lieu of the amendment in the nature of a
4 substitute recommended by the Committee on Ways and
5 Means now printed in the bill, an amendment in the na-
6 ture of a substitute consisting of the text of Rules Com-
7 mittee Print 119–34 shall be considered as adopted. The
8 bill, as amended, shall be considered as read. All points
9 of order against provisions in the bill, as amended, are
10 waived. The previous question shall be considered as or-
11 dered on the bill, as amended, and on any further amend-
12 ment thereto, to final passage without intervening motion
13 except: (1) one hour of debate equally divided and con-
14 trolled by the chair and ranking minority member of the
15 Committee on Ways and Means or their respective des-
16 ignees; and (2) one motion to recommit.

17 SEC. 12. Upon adoption of this resolution it shall be
18 in order without intervention of any point of order to con-
19 sider in the House the resolution (H. Res. 1383) com-
20 memorating the one-year anniversary of the enactment of
21 the Working Families Tax Cuts. The amendment to the
22 preamble printed in part C of the report of the Committee
23 on Rules accompanying this resolution shall be considered
24 as adopted. The resolution, as amended, shall be consid-
25 ered as read. The previous question shall be considered

1 as ordered on the resolution and preamble, as amended,
2 to adoption without intervening motion or demand for di-
3 vision of the question except one hour of debate equally
4 divided and controlled by the chair and ranking minority
5 member of the Committee on Ways and Means or their
6 respective designees.

7 SEC. 13. House Resolution 1377 is laid on the table.

8 SEC. 14. In the engrossment of H.R. 8800, the Clerk
9 shall—

10 (a) add the text of S. 1383, as passed by the House,
11 as new matter at the end of H.R. 8800;

12 (b) assign appropriate designations to provisions
13 within the engrossment;

14 (c) conform cross-references and provisions for short
15 titles within the engrossment; and

16 (d) be authorized to make technical corrections, to
17 include corrections in spelling, punctuation, page and line
18 numbering, section numbering, and insertion of appro-
19 priate headings within the engrossment.
