Mr. SCHIFF (for himself and Mr. KELLY) introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

To provide for limitations on judgments, awards, and compromise settlements under section 1304 of title 31, United States Code.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Payouts for Polit-
5 ical Insiders Act”.

6 **SEC. 2. RESTRICTIONS ON PAYMENTS PURSUANT TO THE**
7 **ANTI-WEAPONIZATION FUND.**

8 (a) IN GENERAL.—Section 1304 of title 31, United
9 States Code, is amended—

10 (1) by adding at the end the following:

1 “(e) No funds shall be authorized for a judgment,
2 award, compromise settlement, interest, or costs for pay-
3 ments administered under the Anti-Weaponization Fund
4 arising pursuant to the settlement agreement in Trump
5 v. Internal Revenue Service, No. 1:26-cv-20609 (S.D.
6 Fla.) to:

7 “(1) The President.

8 “(2) The Vice President.

9 “(3) Any individual employed by the principal
10 campaign committee, authorized committee, or a
11 connected organization (as those terms are defined
12 in section 301 of the Federal Election Campaign Act
13 of 1971 (52 U.S.C. 30101)) of the President or Vice
14 President.

15 “(4) Any other covered executive branch offi-
16 cial, as defined in section 3 of the Lobbying Disclo-
17 sure Act (2 U.S.C. 1602).

18 “(5) A United States Senator, a Representative
19 in Congress, a Delegate to Congress, or the Resident
20 Commissioner from Puerto Rico.

21 “(6) An officer or employee of the Congress
22 whose compensation is disbursed by the Secretary of
23 the Senate or the Chief Administrative Officer of the
24 House of Representatives.”; and

1 (2) in subsection (d), by adding at the end the
2 following:

3 “(7) With respect to any payment administered
4 under the Anti-Weaponization Fund arising pursu-
5 ant to the settlement agreement in *Trump v. Inter-*
6 *nal Revenue Service*, No. 1:26-cv-20609 (S.D. Fla.),
7 not later than 180 days in advance of a payment,
8 the name of the recipient, the amount, a complete
9 summary of the basis of the claim, and the name of
10 counsel of the claimant.”.

11 (b) **APPLICABILITY.**—This section, and the amend-
12 ments made by this section, shall apply to any pending
13 case or any cause of action arising on or after January
14 20, 2025.
