LONG TITLE

General Description:

This bill addresses the distribution of facility-provided medication to patients under certain circumstances

Highlighted Provisions:

This bill:

- ▶ permits certain health facilities to offer the unused portion of a facility-owned medication to the patient under certain circumstances;
- ▶ requires that a facility-provided medication be labeled in accordance with the Pharmacy Practice Act;
- ▶ addresses counseling to patients regarding facility-provided medication;
- ▶ defines terms; and
- ▶ makes technical and conforming changes.

Other Special Clauses:

This bill provides a coordination clause.

46 States Food and Drug Administration, to prevent pregnancy after sexual intercourse.

47 (8) "Facility-provided medication" means a topical antibiotic, anti-inflammatory, dilation,
48 or glaucoma drop or ointment that is:

49 (a) provided in an operating room, emergency department, or ambulatory surgical
50 facility; and

51 (b)(i) retrieved from a dispensing system during a procedure or visit; or

52 (ii) ordered at least 24 hours in advance and kept on standby for a specific patient's
53 procedure or visit.

54 [(7)] (9) "Freestanding urgent care center" means the same as that term is defined in Section
55 59-12-801.

56 [(8)] (10) "General acute hospital" means the same as that term is defined in Section
57 26B-2-201.

58 [(9)] (11) "Health care facility" means a hospital, a hospice inpatient residence, a nursing
59 facility, a dialysis treatment facility, an assisted living residence, an entity that provides
60 home- and community-based services, a hospice or home health care agency, or another
61 facility that provides or contracts to provide health care services, which facility is
62 licensed under Chapter 2, Part 2, Health Care Facility Licensing and Inspection.

- 72 ~~[(13)]~~ (15) "Opiate antagonist" means naloxone hydrochloride or any similarly acting drug
- 73 that is not a controlled substance and that is approved by the federal Food and Drug
- 74 Administration for the diagnosis or treatment of an opiate-related drug overdose.
- 75 ~~[(14)]~~ (16) "Opiate-related drug overdose event" means an acute condition, including a
- 76 decreased level of consciousness or respiratory depression resulting from the
- 77 consumption or use of a controlled substance, or another substance with which a
- 78 controlled substance was combined, and that a person would reasonably believe to
- 79 require medical assistance.

- 81 (a) a law enforcement agency;
- 82 (b) a fire department;
- 83 (c) an emergency medical service provider, as defined in Section 53-2d-101;
- 84 (d) emergency medical service personnel, as defined in Section 53-2d-101;
- 85 (e) an organization providing treatment or recovery services for drug or alcohol use;
- 86 (f) an organization providing support services for an individual, or a family of an
- 87 individual, with a substance use disorder;
- 88 (g) a certified peer support specialist, as defined in Section 26B-5-610;
- 89 (h) an organization providing substance use or mental health services under contract
- 90 with a local substance abuse authority, as defined in Section 26B-5-101, or a local
- 91 mental health authority, as defined in Section 26B-5-101;
- 92 (i) an organization providing services to the homeless;
- 93 (j) a local health department;
- 94 (k) an individual licensed to practice under:
- 95 (i) Title 58, Chapter 17b, Pharmacy Practice Act;
- 96 (ii) Title 58, Chapter 60, Part 2, Social Worker Licensing Act; or

112 a hormonal vaginal ring, and a hormonal contraceptive patch.
- 113 (c) "Self-administered hormonal contraceptive" does not include any drug intended to
114 induce an abortion, as that term is defined in Section 76-7-301.
- 115 ~~[(23)]~~ (25)(a) "Sexual assault" means any criminal conduct described in Title 76, Chapter
116 5, Part 4, Sexual Offenses, that may result in a pregnancy.
- 117 (b) "Sexual assault" does not include criminal conduct described in:
- 118 (i) Section 76-5-417, enticing a minor;
- 119 (ii) Section 76-5-418, sexual battery;
- 120 (iii) Section 76-5-419, lewdness; or
- 121 (iv) Section 76-5-420, lewdness involving a child.
- 122 ~~[(24)]~~ (26) "Victim of sexual assault" means any person who presents to receive, or
123 receives, medical care in consequence of being subjected to sexual assault.
- 124 Section 2. Section **26B-4-516** is enacted to read:
- 125 **26B-4-516 . Facility-provided medication -- Use and distribution.**
- 126 (1) When a facility-provided medication is administered to a patient, any unused portion of
127 the facility-provided medication may be offered to the patient upon discharge if the
128 medication is required for continued treatment.
- 129 (2) A facility-provided medication offered to a patient under this section shall be labeled in
130 compliance with Title 58, Chapter 17b, Pharmacy Practice Act.

131 (3) If a facility-provided medication is used in an operating room or emergency department,
132 the facility is responsible for providing the patient with counseling on the medication's
133 proper use and administration.

134 (4) The pharmacist counseling requirement described in Section 58-17b-613 does not apply
135 to a facility-provided medication dispensed in accordance with this section.

136 Section 3. **Effective Date.**

137 This bill takes effect on May 6, 2026.

138 Section 4. **Coordinating H.B. 97 with H.B. 301**

139 If this H.B. 97, Medical Waste Amendments, and H.B. 301, Drug Recodification, both
140 pass and become law, the Legislature intends that, on May 6, 2026, the amendments to
141 Subsection 26B-4-501(2) in H.B. 97 shall supersede the amendments to Subsection
142 26B-4-501(1) in H.B. 301.
