17 *Be it enacted by the Legislature of the state of Utah:*

18 Section 1. Section **20A-2-208** is enacted to read:

19 **20A-2-208 . Voter registration forms and information available at Division of**
 20 **Wildlife Resources offices.**

21 (1) As used in this section:

22 (a) "Applicant" means an individual who is:

23 (i) seeking to purchase a hunting or fishing license in-person at a Division of Wildlife
 24 Resources office; and

25 (ii) eligible to register to vote under Section 20A-2-101 or to preregister to vote under
 26 Section 20A-2-101.1.

27 (b) "Voter registration information" means information provided by the lieutenant
 28 governor, including:

- 31 (i) instructions for registering to vote;
 32 (ii) voter registration deadlines; and
 33 (iii) contact information for questions about voter registration.

34 (2) The lieutenant governor shall provide voter registration forms and voter registration
 35 information to each Division of Wildlife Resources office.

36 (3)(a) An applicant may receive a voter registration form when purchasing a hunting or
 37 fishing license at a Division of Wildlife Resources office in accordance with this
 38 Subsection (3).
