*Be it enacted by the Legislature of the state of Utah:*

Section 1. Section **76-13-205** is amended to read:

**76-13-205 . Dog fighting.**

(1)(a) As used in this section, "dog fighting paraphernalia" means a breaking stick, treadmill, wheel, hot walker, cat mill, cat walker, jenni, or other item meant to train a dog to fight with another dog.

(b) Terms defined in Sections 76-1-101.5, 76-13-101, and 76-13-201 apply to this

32 (2) An actor commits dog fighting if the actor:

33 (a) owns, possesses, keeps, or trains a dog with the intent to engage the dog in [~~an~~

75 (1)(a) As used in this section:

76 (i) "Game fowl" means a fowl reared or used for fighting other fowl.

77 (ii) "Promote" means to engage in promoting, producing, or staging events or  
 78 activities that involve game fowl fighting.

79 (b) Terms defined in Sections 76-1-101.5, 76-13-101, and 76-13-201 apply to this  
 80 section.

81 (2) An actor commits game fowl fighting if the actor intentionally or knowingly:
