The Natural Resources, Agriculture, and Environment Interim Committee recommended this bill.

Legislative Vote: 10 voting for 0 voting against 9 absent

General Description:

This bill addresses the regulation of pest control.

Highlighted Provisions:

This bill:

- modifies the definition provision;
- addresses rulemaking and requires reporting regarding rulemaking;
- removes certain language regarding liability;
- amends provisions related to a pesticide applicator business, including:
 - modifying fee requirements;
 - repealing the qualified party concept; and
 - providing for a registration established by rule;
- provides for permitting of ornamental and turf technicians, including fine amounts;
- provides for permitting of certain salespersons; and
- makes technical and conforming amendments.

38 Section 1. Section **4-14-102** is amended to read:

39 **4-14-102 . Definitions.**

40 As used in this chapter:

41 (1) "Active ingredient" means an ingredient that:

42 (a) prevents, destroys, repels, controls, or mitigates pests; or

43 (b) acts as a plant regulator, defoliant, or desiccant.

44 [~~(2) "Adulterated pesticide" means a pesticide with a strength or purity that is below the~~
45 ~~standard of quality expressed on the label under which the pesticide is offered for sale.]~~

46 [~~(3)~~ (2) "Animal" means [aH] a vertebrate or invertebrate species.

47 [~~(4)~~ (3) "Beneficial insect" means an insect that is:

48 (a) an effective pollinator of plants;

49 (b) a parasite or predator of pests; or

50 (c) otherwise beneficial.

51 [~~(5)~~ (4) "Certified applicator" means an individual who is licensed by the department to
52 apply:

53 (a) a restricted use pesticide; or

75 rust, smut, mildew, mold, yeast, and bacteria.

110 saclike bodies covered with cuticle, also known as nemas or eelworms.

132 (b) any substance or mixture of substances intended to be used as a plant regulator,

135 adhesive, or emulsifying agent with deflocculating properties of its own used with a
136 pesticide to aid the pesticide's application or effect; and

- 146 [(28)] (26) "Pesticide dealer" means any person who distributes restricted use pesticides.
- 147 [(29)] (27)(a) "Plant regulator" means any substance or mixture intended, through
148 physiological action, to accelerate or retard the rate of growth or rate of maturation,
149 or otherwise alter the behavior of ornamental or crop plants.
- 150 (b) "Plant regulator" does not include plant nutrients, trace elements, nutritional
151 chemicals, plant inoculants, or soil amendments.
- 152 [(30) "Qualifying party" means a certified qualified applicator who is the owner or
153 employee of a pesticide applicator business and who is registered with the department as
154 the individual responsible for ensuring the training, equipping, and supervision of all
155 pesticide applicators who work for the pesticide applicator business.]

- 157 (a) a pesticide, including a highly toxic pesticide, that is a serious hazard to beneficial
158 insects, animals, or land; or

 169 more than 5% of the potential treatment area or one-twentieth of an acre, whichever is
 170 smaller, using equipment that is designed to contain no more than five gallons of
 171 mixture.]

172 [~~(33)~~] (32) "Weed" means any plant that grows where not wanted.

173 [~~(34)~~] (33) "Wildlife" means [~~all~~] living things that are neither human, domesticated, nor
 174 pests.

176 **4-14-106 . Department authorized to make and enforce rules.**

177 (1) The department may, [~~by following the procedures and requirements of~~] in
 178 accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act, [~~adopt~~]
 179 make rules to:

180 [~~(1)~~] (a) declare as a pest any form of plant or animal life that is injurious to health or the
 181 environment, except:

182 [~~(a)~~] (i) a human being; or

183 [~~(b)~~] (ii) a bacteria, virus, or other microorganism on or in a living person or animal;

184 [~~(2)~~] (b) establish, in accordance with the regulations issued by the EPA under 7 U.S.C.

207 **4-14-108 . Suspension or revocation -- Stop sale, use, or removal order**
 208 **authorized -- Court action -- Award of costs authorized -- Fines.**

209 (1) The department may revoke or suspend the registration of [any] a pesticide upon
 210 satisfactory evidence that the registrant has used fraudulent or deceptive practices in the
 211 registration of the pesticide or in the pesticide's distribution in this state.

212 (2)(a) The department may issue a "stop sale, use, or removal order" to the owner or
 213 distributor of [any] a designated pesticide or lot of pesticide that the department finds
 214 or has reason to believe is being offered or exposed for sale in violation of this
 215 chapter.

216 (b) The order described in Subsection (2)(a) shall be in writing and no pesticide subject
 217 to the order shall be moved, offered, or exposed for sale, except upon the subsequent
 218 written release by the department.

219 (c) Before a release is issued, the department may require the owner or distributor of the
 220 "stopped" pesticide or lot to pay the expense incurred by the department in
 221 connection with the withdrawal of the product from the market.

 263 any rules issued in accordance with this chapter.

 265 ~~pesticide unless the person was negligent.]~~

267 **4-14-111 . Registration required for a pesticide applicator business.**

268 (1) A pesticide applicator business shall register with the department by:

- 269 (a) submitting an application on a form provided by the department;
 270 (b) paying the registration fee; and
 271 (c) certifying that the business is in compliance with this chapter and departmental rules
 272 authorized by this chapter.
- 273 (2)(a) By following the procedures and requirements of Section 63J-1-504, the
 274 department shall establish a registration fee~~[-based on the number of pesticide
 275 applicators employed by the pesticide applicator business].~~
- 276 (b)(i) Notwithstanding Section 63J-1-504, the department shall deposit the fees as
 277 dedicated credits and may only use the fees to administer and enforce this chapter.
 278 (ii) The Legislature may annually designate the revenue generated from the fee as
 279 nonlapsing in an appropriations act.

- 330 commercially applying a herbicide that is:
- 331 (i) classified as a general use pesticide with a "caution" or "warning" signal word on
- 332 the product label; and
- 333 (ii) being applied for ornamental and turf weed pest control.
- 334 (b) An individual may obtain a permit under this Subsection (1) by:
- 335 (i) submitting an application on a form provided by the department;
- 336 (ii) showing evidence of completing the training required under Subsection (1)(c);

- 337 (iii) having no outstanding infractions and owing no money to the department; and

382 application of a pesticide.

- 393 (5) The department may:
- 394 (a) deny an application for a permit under this section;
395 (b) revoke a permit under this section for cause; or
396 (c) suspend a permit under this section for cause.
- 397 (6)(a) If a permit is revoked or suspended under Subsection (5), the individual holding
398 the permit shall return the permit to the department within 14 days after the day on
399 which the individual receives notice of the revocation or suspension.
- 400 (b) An individual who fails to return a permit, as described in Subsection (6)(a), is
401 subject to an administrative fine of up to \$100 for each 14 days the individual does
402 not return the permit.

403 **Section 8. Effective Date.**
