2 **LONG TITLE**

3 **General Description:**

4 This bill creates requirements for certain enforcement activities.

5 **Highlighted Provisions:**

6 This bill:

- 7
- 8 ▶ defines terms;
 - 9 ▶ prohibits certain state or local law enforcement officers from assisting with a federal
 - 10 immigration enforcement operation in a sensitive location or house of worship;
 - 11 ▶ prohibits, with certain exceptions, an employee of a law enforcement agency from using a
 - 12 facial covering;
 - 13 ▶ provides:
 - 14 • a criminal penalty for an illegal use of a facial covering;
 - 15 • a waiver of immunity and allowance for damages against an employee of a law
 - 16 enforcement agency who violates the facial mask prohibition and commits a specified
 - 17 offense; and
 - 18 • an exemption from the criminal penalty if the employing law enforcement agency has
 - 19 established and publicly posted a facial covering policy;
 - 20 ▶ requires a law enforcement agency to establish and publicly post a facial covering policy
 - 21 and includes requirements for a law enforcement facial covering policy;
 - 22 ▶ requires, with certain exceptions, a governmental entity operating a sensitive location to
 - 23 not allow into certain non-public areas an individual who is seeking access to conduct an
 - 24 immigration enforcement operation;
 - 25 ▶ contains severability clauses; and
 - 26 ▶ makes technical and conforming changes.

39 *Be it enacted by the Legislature of the state of Utah:*40 Section 1. Section **53-13-106.14** is enacted to read:

41 **53-13-106.14 . Prohibition on state or local law enforcement assistance with**
 42 **federal civil immigration enforcement in a sensitive location or a house of worship --**
 43 **Exceptions.**

44 (1) As used in this section:

45 (a) "Federal immigration authority" means the United States Department of Homeland
 46 Security, the United States Immigration and Customs Enforcement, the United States
 47 Citizenship and Immigration Services, the United States Customs and Border
 48 Protection, or any other federal agency or entity that has the authority to detect,
 49 investigate, or enforce a violation of federal immigration law.

50 (b) "Federal immigration employee" means an individual:51 (i) who is employed by a federal immigration authority; and52 (ii) whose duties include the investigation or enforcement of federal immigration
53 laws.54 (c) "House of worship" means the same as that term is defined in Section 76-11-201.55 (d) "Immigration enforcement operation" means an operation in which the primary
56 objective is the identification or apprehension of an individual for the purpose of
57 subjecting the individual to civil immigration detention, removal, or deportation
58 proceedings.59 (e) "Law enforcement officer" means the same as that term is defined in Section
60 53-13-103.61 (f) "Sensitive location" means the same as that term is defined in Section 63G-34-101.62 (2) Except as provided in Subsection (3), a state or local law enforcement agency may not
63 provide resources, equipment, facilities, personnel, or other assistance to a federal
64 immigration authority or a federal immigration employee for the purpose of an

65 immigration enforcement operation in a sensitive location or a house of worship.
 66 (3) A state or local law enforcement agency may provide resources, equipment, facilities,
 67 personnel, or other assistance to a federal immigration authority or a federal immigration
 68 employee for the purpose of an immigration enforcement operation in a sensitive
 69 location or a house of worship if:

- 70 (a) circumstances exist that pose an imminent threat of:
 71 (i) physical harm to an individual; or
 72 (ii) physical damage to the sensitive location or a house of worship;
 73 (b) the entity responsible for operating the sensitive location or house of worship
 74 requests the assistance or presence of a state or local law enforcement agency or a
 75 law enforcement officer employed by a state or local law enforcement agency; or
 76 (c) the immigration enforcement operation is conducted in accordance with a federal
 77 criminal warrant or in exigent circumstances.

78 Section 2. Section **53-25-106** is enacted to read:

79 **53-25-106 . Prohibition on officer use of a facial covering -- Exceptions --**

80 **Criminal penalty -- Civil claim.**

- 81 (1) For purposes of this section:
 82 (a)(i) "Facial covering" means an opaque mask, garment, helmet, headgear, or other
 83 item that conceals or obscures the facial identity of an individual.
 84 (ii) "Facial covering" includes a balaclava, tactical mask, gator, or ski mask.
 85 (iii) "Facial covering" does not include:
 86 (A) a translucent face shield or clear mask that does not conceal the individual's
 87 facial identity;
 88 (B) a medical or surgical mask, gas mask, helmet, respirator, or self-contained
 89 breathing apparatus, if worn to protect against exposure to a hazardous or
 90 harmful condition;
 91 (C) a mask, helmet, self-contained breathing apparatus, or other device necessary
 92 for underwater use that is worn during a water-based operation;
 93 (D) a motorcycle helmet when worn by an officer using a motorcycle or other
 94 vehicle that requires a helmet for the safe operation of the vehicle; or
 95 (E) protective eyewear, helmets, sunglasses, or other standard law enforcement
 96 gear not designed or used for the purpose of hiding an individual's identity.
 97 (b) "Officer" means an individual:
 98 (i) who is an employee of a law enforcement agency; and

- 99 (ii) whose primary and principal duties consist of the prevention and detection of
100 crime and the enforcement of criminal or immigration statutes or ordinances of the
101 federal government, this state, or a political subdivision of this state.
- 102 (c) "Tactical unit" means a special group within a law enforcement agency that is
103 specifically trained and equipped to respond to critical, high-risk situations.
- 104 (2) Except as provided in Subsection (3), an officer may not wear a facial covering that
105 conceals or obscures the officer's facial identity in the performance of the officer's
106 official duties.
- 107 (3) An officer may wear a facial covering described in Subsection (2) if:
- 108 (a) the officer is actively performing duties associated with a tactical unit in which
109 protective gear is required for the officer's physical safety;
- 110 (b) the officer is actively participating in an undercover operation or assignment,
111 including in a prosecution related to an undercover operation or assignment, that is
112 authorized by the officer's supervising personnel or a court order;
- 113 (c) the use of the facial covering is authorized under a written facial covering policy
114 established by the officer's employing law enforcement agency in accordance with
115 Section 53-25-903; or
- 116 (d) the officer in good faith believes that the use of the facial covering was permitted by
117 law or by the officer's law enforcement agency.
- 118 (4)(a) Except as provided in Subsection (4)(b), an officer's intentional violation of this
119 section on or after July 1, 2026, is a class C misdemeanor.
- 120 (b) An officer may not be prosecuted for a violation of this section if the officer:
- 121 (i) was acting in the officer's official capacity as an employee of a law enforcement
122 agency; and
- 123 (ii) the officer's employing law enforcement agency, at the time of the violation, had
124 created and publicly posted a written facial covering policy in accordance with
125 Section 53-25-903.
- 126 (5) An officer who is found to have committed an assault, battery, false imprisonment, false
127 arrest, abuse of process, or malicious prosecution against an individual while wearing a
128 facial covering in a knowing violation of this section, may not assert a privilege or
129 immunity for the officer's tortious conduct against a claim of civil liability, and is liable
130 to the individual for the greater of actual damages or statutory damages of not less than
131 \$10,000, whichever is greater.
- 132 (6) The provisions of this section are severable, and if any subsection of this section or the

133 application of any subsection to any person or circumstance is held invalid by a final
134 decision of a court with jurisdiction, the remainder of this section shall be given effect
135 without the invalid subsection or application.

136 Section 3. Section **53-25-903** is enacted to read:

137 **53-25-903 . Law enforcement agency policy concerning facial coverings.**

- 138 (1) As used in this section, "tactical unit" means the same as that term is defined in Section
139 53-25-106.
- 140 (2) Beginning July 1, 2026, a law enforcement agency operating in the state shall create,
141 maintain, and publicly post a written policy regarding the use of facial coverings by
142 employees of the law enforcement agency.
- 143 (3) The policy described in Subsection (2) shall include:
- 144 (a) a purpose statement affirming the law enforcement agency's commitment to:
- 145 (i) transparency, accountability, and public trust;
- 146 (ii) restricting the use of facial coverings to specific, clearly defined, and limited
147 circumstances; and
- 148 (iii) the principle that generalized and undifferentiated fear and apprehension about
149 officer safety is not sufficient to justify the use of a facial covering;
- 150 (b) a general prohibition on an officer's use of a facial covering when performing the
151 officer's official duties as an officer and the following exceptions:
- 152 (i) the exceptions described in Subsections 53-25-106(3)(a) and (b); and
- 153 (ii) a law or policy regarding:
- 154 (A) a reasonable accommodation for an officer to wear a facial covering based on
155 the officer's disability or other medical reason; or
- 156 (B) the use of a facial covering by an officer when required by occupational health
157 or safety laws;
- 158 (c) the use of the definition of "facial covering" found in Section 53-25-106; and
- 159 (d) a requirement that a supervisor may not knowingly allow an employee of the law
160 enforcement agency to violate state law or agency policy concerning the use of a
161 facial covering.
- 162 (4) The provisions of this section are severable, and if any subsection of this section or the
163 application of any subsection to any person or circumstance is held invalid by a final
164 decision of a court with jurisdiction, the remainder of this section shall be given effect
165 without the invalid subsection or application.

166 Section 4. Section **63G-34-101** is enacted to read:

167 **CHAPTER 34. Limitation on Federal Immigration Actions in Sensitive Locations**168 **63G-34-101 . Definitions.**169 As used in this chapter:170 (1) "Governmental entity" means:171 (a) the state; or172 (b) a political subdivision.173 (2) "Immigration enforcement operation" means the same as that term is defined in Section
174 53-13-106.14.175 (3) "Political subdivision" means the same as that term is defined in Section 63G-7-102.176 (4) "Public library" means a library established under Section 9-7-402 or 9-7-501.177 (5)(a) "Sensitive location" means:178 (i) a public library;179 (ii) a health care facility operated by a governmental entity;180 (iii) a courthouse; or181 (iv) a location operated by a governmental entity that provides:182 (A) physical or mental health services;183 (B) shelter care services; or184 (C) legal services.185 (b) "Sensitive location" does not include:186 (i) a correctional or detention facility operated by a governmental entity; or187 (ii) a holding or detention facility in a courthouse operated by a governmental entity.188 (6) "State" means the same as that term is defined in Section 63G-7-102.189 Section 5. Section **63G-34-102** is enacted to read:190 **63G-34-102 . Limitations on federal immigration actions in a sensitive location.**191 A governmental entity operating a sensitive location shall deny access to any portion of
192 the sensitive location that is not accessible to the general public to any individual who is
193 seeking access to conduct an immigration enforcement operation, unless:194 (1) the individual presents a valid warrant issued by a federal court;195 (2) circumstances exist that pose an imminent threat of:196 (a) physical harm to an individual; or197 (b) physical damage to the sensitive location; or198 (3) exigent circumstances exist.199 Section 6. **Effective Date.**200 This bill takes effect on May 6, 2026.
