This bill amends provisions related to domestic relations.

This bill:

8

- amends definitions for, and the use of, "parent" and "natural parent" throughout the Utah

9

Code to reflect the definition of a parent-child relationship under Title 81, Chapter 5,

10

Uniform Parentage Act;

11

- creates definitions related to the definition of "parent";

12

- requires the Office of Recovery Services to review the requirements for calculating a

13

minimal child support award for a child support order and to report to the Judiciary

14

Interim Committee regarding the review;

15

- clarifies language regarding the parent-child relationship for purposes of intestate

16

succession;

17

- provides that the district court of each judicial district assign any case or proceeding

18

involving the same child or family to a single judge;

19

- modifies the requirements for a marriage license with regard to parties that are not

20

physically present in the state in the same location as the officiant;

21

- provides that a man is not presumed to be the father of a child in certain circumstances;

22

- addresses the authority of a court to deny a motion for genetic testing, or disregard

23

genetic test results, in a parentage proceeding;

24

- defines terms related to child support;

25

- modifies the requirements for child care expenses in a child support order, including the

26

requirements for a minimal child care award;

27

- provides that the base child support award is automatically adjusted for the remaining

28

children in the child support order when parental rights to a child are terminated for the

- 29 parent who is obligated to pay child support;
- 30 ▶ creates a table for the purposes of establishing a minimal child care award for certain
31 child support orders entered or modified on or after January 1, 2027;
- 32 ▶ clarifies the list of offenses requiring notification when a parent is residing with an
33 individual, or providing an individual with access to the parent's minor child, who has
34 been convicted of an offense;
- 35 ▶ provides that a court may not require a parent in a custody and parent-time proceeding to
36 disclose the parent's address if the parent relocated due to domestic violence or family
37 violence by the other parent;
- 38 ▶ addresses the establishment and modification of a parent-time schedule;
- 39 ▶ clarifies the list of offenses related to when a court may order supervised parent-time;
- 40 ▶ clarifies, for purposes of modifying custody due to a substantial and material change, the
41 list of offenses for when a parent is residing with an individual, or providing an
42 individual with access to the parent's minor child, and the parent knows that the
43 individual has been convicted of an offense;
- 44 ▶ addresses a change of custody or parent-time for a minor child who turns five years old;
- 45 ▶ addresses make-up parent-time when a parent has been denied parent-time due to an
46 investigation by the Division of Child and Family Services;
- 47 ▶ modifies the parent-time requirements upon the relocation of a parent;
- 48 ▶ addresses telephone contact and virtual parent-time for a noncustodial parent when a
49 parent relocates;
- 50 ▶ requires the time periods for extended parent-time by a parent for summer break or
51 off-track time to be consecutive;
- 52 ▶ modifies the parent-time schedules to address consistency issues;
- 53 ▶ modifies the parent-time schedules for Mother's Day and Father's Day;
- 54 ▶ removes Columbus Day and Veterans Day as holidays in the parent-time schedules;
- 55 ▶ clarifies the list of offenses regarding when a court cannot grant custody to an individual
56 who is convicted, pleads guilty, or pleads no contest to an offense;
- 57 ▶ makes technical and conforming corrections;
- 58 ▶ includes a coordination clause to modify a term if this bill and H.B. 30, Human
59 Trafficking, Exploitation, and Smuggling Amendments, both pass and become law; and
- 60 ▶ includes a coordination clause to address a substantive conflict with the parent-time
61 schedule for Juneteenth National Freedom Day if this bill and H.B. 309, Juneteenth

62 Observance Amendments, both pass and become law.

139 Section 1. Section **13-76-101** is amended to read:

140 **13-76-101 . Definitions.**

141 As used in this chapter:

- 142 (1) "Age category" means one of the following categories of individuals based on age:
- 143 (a) "child" which means an individual who is under 13 years old;
- 144 (b) "younger teenager" which means an individual who is at least 13 years old and under
- 145 16 years old;
- 146 (c) "older teenager" which means an individual who is at least 16 years old and under 18
- 147 years old; or
- 148 (d) "adult" which means an individual who is at least 18 years old.
- 149 (2) "Age category data" means information about a user's age category that is:
- 150 (a) collected by an app store provider; and
- 151 (b) shared with a developer.
- 152 (3) "Age rating" means a classification that provides an assessment of the suitability of an
- 153 app's content for different age groups.
- 154 (4) "App" means a software application or electronic service that a user may run or direct
- 155 on a mobile device.
- 156 (5) "App store" means a publicly available website, software application, or electronic
- 157 service that allows users to download apps from third-party developers onto a mobile
- 158 device.
- 159 (6) "App store provider" means a person that owns, operates, or controls an app store that
- 160 allows users in the state to download apps onto a mobile device.
- 161 (7) "Content description" means a description of the specific content elements that informed
- 162 an app's age rating.
- 163 (8) "Developer" means a person that owns or controls an app made available through an

- 164 app store in the state.
- 165 (9) "Division" means the Division of Consumer Protection, established in Section 13-2-1.
- 166 (10) "Knowingly" means to act with actual knowledge or to act with knowledge fairly
167 inferred based on objective circumstances.
- 168 (11) "Minor" means an individual under 18 years old.
- 169 (12) "Minor account" means an account with an app store provider that:
- 170 (a) is established by an individual who the app store provider has determined is under 18
171 years old through the app store provider's age verification methods; and
- 172 (b) requires affiliation with a parent account.
- 173 (13) "Mobile device" means a phone or general purpose tablet that:
- 174 (a) provides cellular or wireless connectivity;
- 175 (b) is capable of connecting to the ~~[Internet]~~ internet;
- 176 (c) runs a mobile operating system; and
- 177 (d) is capable of running apps through the mobile operating system.
- 178 (14) "Mobile operating system" means software that:
- 179 (a) manages mobile device hardware resources;
- 180 (b) provides common services for mobile device programs;
- 181 (c) controls memory allocation; and
- 182 (d) provides interfaces for applications to access device functionality.
- 183 (15) "Parent" means, with respect to a minor, any of the following individuals who have
184 legal authority to make decisions on behalf of the minor:
- 185 ~~[(a) an individual with a parent-child relationship under Section 78B-15-201;]~~
- 186 (a) an individual who has a parent-child relationship, as defined in Section 81-5-102,
187 with the minor;
- 188 (b) a legal guardian; or
- 189 (c) an individual with legal custody.
- 190 (16) "Parent account" means an account with an app store provider that:
- 191 (a) is verified to be established by an individual who the app store provider has
192 determined is at least 18 years old through the app store provider's age verification
193 methods; and
- 194 (b) may be affiliated with one or more minor accounts.
- 195 (17) "Parental consent disclosure" means the following information that an app store
196 provider is required to provide to a parent before obtaining parental consent:
- 197 (a) if the app store provider has an age rating for the app or in-app purchase, the app's or

- 198 in-app purchase's age rating;
- 199 (b) if the app store provider has a content description for the app or in-app purchase, the
- 200 app's or in-app purchase's content description;
- 201 (c) a description of:
- 202 (i) the personal data collected by the app from a user; and
- 203 (ii) the personal data shared by the app with a third party; and
- 204 (d) if personal data is collected by the app, the methods implemented by the developer to
- 205 protect the personal data.

206 (18) "Significant change" means a material modification to an app's terms of service or

207 privacy policy that:

- 208 (a) changes the categories of data collected, stored, or shared;
- 209 (b) alters the app's age rating or content descriptions;
- 210 (c) adds new monetization features, including:
- 211 (i) in-app purchases; or
- 212 (ii) advertisements; or
- 213 (d) materially changes the app's:
- 214 (i) functionality; or
- 215 (ii) user experience.

216 (19) "Verifiable parental consent" means authorization that:

- 217 (a) is provided by an individual who the app store provider has verified is an adult;
- 218 (b) is given after the app store provider has clearly and conspicuously provided the
- 219 parental consent disclosure to the individual; and
- 220 (c) requires the parent to make an affirmative choice to:
- 221 (i) grant consent; or
- 222 (ii) decline consent.

265 **26B-8-301 . Definitions.**

266 As used in this part:

- 267 (1) "Adult" means an individual who is at least 18 years old.
- 268 (2) "Agent" means an individual:
- 269 (a) authorized to make health care decisions on the principal's behalf by a power of
- 270 attorney for health care; or
- 271 (b) expressly authorized to make an anatomical gift on the principal's behalf by any
- 272 other record signed by the principal.
- 273 (3) "Anatomical gift" means a donation of all or part of a human body to take effect after
- 274 the donor's death for the purpose of transplantation, therapy, research, or education.
- 275 (4) "Decedent" means:
- 276 (a) a deceased individual whose body or part is or may be the source of an anatomical
- 277 gift; and
- 278 (b) includes:
- 279 (i) a stillborn infant; and
- 280 (ii) subject to restrictions imposed by law other than this part, a fetus.
- 281 (5)(a) "Disinterested witness" means:
- 282 (i) a witness other than the spouse, child, parent, sibling, grandchild, grandparent, or
- 283 guardian of the individual who makes, amends, revokes, or refuses to make an
- 284 anatomical gift; or

- 293 (8) "Donor registry" means a database that contains records of anatomical gifts and
- 294 amendments to or revocations of anatomical gifts.
- 295 (9) "Driver license" means a license or permit issued by the Driver License Division of the
- 296 Department of Public Safety, to operate a vehicle, whether [~~or not~~] conditions are
- 297 attached to the license or permit.
- 298 (10) "Eye bank" means a person that is licensed, accredited, or regulated under federal or
- 299 state law to engage in the recovery, screening, testing, processing, storage, or

4401 the person intends to intervene in or contest the adoption;
- 4402 (b) shall state the consequences, described in Subsection (6)(b), for failure of a person to
4403 file a motion for relief within 30 days after the day on which the person is served
4404 with notice of an adoption proceeding;

- 4405 (c) is not required to include, or be accompanied by, a summons or a copy of the petition
4406 for adoption;
- 4407 (d) shall state where the person may obtain a copy of the petition for adoption; and
4408 (e) shall indicate the right to the appointment of counsel for a party whom the court
4409 determines is indigent and at risk of losing the party's parental rights.
- 4410 (6)(a) A person who has been served with notice of an adoption proceeding and who
4411 wishes to contest the adoption shall file a motion to intervene in the adoption
4412 proceeding:
- 4413 (i) within 30 days after the day on which the person was served with notice of the
4414 adoption proceeding;
- 4415 (ii) setting forth specific relief sought; and
4416 (iii) accompanied by a memorandum specifying the factual and legal grounds upon

- 4418 (b) A person who fails to fully and strictly comply with all of the requirements described

4429 shall designate the content of the notice regarding the identity of the parties.

- 4435 (ii) If the service described in Subsection (7)(b)(i) cannot be completed after two
4436 attempts, the court may issue an order providing for service by publication,
4437 posting, or by any other manner of service.
- 4438 (c) Notice to an individual, who has initiated a parentage proceeding and filed notice of

4439 that action with the office in accordance with the requirements of Subsection (3),
4440 shall be served by certified mail, return receipt requested, at the last address filed

4442 (8) The notice required by this section may be waived in writing by the person entitled to
4443 receive notice.

4444 (9) Proof of service of notice on all persons for whom notice is required by this section

4447 proceeding nor any process in that proceeding is required to contain the name of the
4448 person or persons seeking to adopt the child adoptee.

4450 81-13-212 or 81-13-213, the sole purpose of notice under this section is to enable the

4452 (a) intervene in the adoption; and

4476 birth mother's relinquishment of the child adoptee for adoption;
- 4477 (e) consistent with Subsection (3), an individual who has executed and filed a voluntary
4478 declaration of paternity with the office in accordance with Chapter 5, Uniform
4479 Parentage Act, before the birth mother's execution of consent to adoption or the birth
4480 mother's relinquishment of the child adoptee for adoption;
- 4481 (f) an unmarried biological father of the child adoptee, whose consent is not required
